- V. 2018 Subcontractors Presentation: Elena Salais, Access Support Network, and Melissa Kendrick, Food Bank Monterey County, both 2018 MCCAP subcontractors, shared information on what services are provided by their organizations and how funds awarded by MCCAP significantly impact resources available to the low-income population in Monterey County.
